## **Notes**

With respect to Partial Fee Remission for TAs, Associates, Readers, Tutors/Remedial Tutors, and GSRs at appointments of at least 25%, the current Collective Bargaining Agreement stipulates that the University shall provide a Partial Fee Remission of 100% of Tuition, Student Service Fees, Campus Based Fees, and Student Health Insurance. The remissions quoted above are consistent with the terms of the current contract, and current levels of fee remission are in effect until the Spring '24 quarter. Please be aware that future wages, terms, and conditions are subject to modification based on the collective bargaining process.

Graduate Student Fee Remission applies Fall, Winter and Spring Quarters to eligible registered graduate student academic appointees. GSRs whose appointments total at least 25% but less than 35% and meet all other criteria are eligible for Partial Fee Remission and University of California Student Health Insurance Plan (UC SHIP) credit. GSRs who are appointed at least 35% and meet all other criteria qualify for a Full Fee Remission and UC SHIP credit.

**UC Student Health Insurance**: Health insurance is mandatory. Graduate students may have the UC SHIP fee waived by proving to Student Health Service that they have comparable coverage under another health insurance policy.
